My name is Brenda Hommel. I live at 10133 Queens Circle, Ocean City, MD. I have been a teacher for Worcester County for 29 years. I am not able to be at the budget hearing since I am working tonight. With the current cost of living and a salary that has not kept up, I have been working 9 jobs to try to pay my bills and put my son through college without incurring any debt. I work up to 4 jobs in a single day and usually average 93 hours per week. I no longer drive my car to save on gas, so I ride my bike 13 – 20 miles per day to and from work. I will be working at least 5 jobs this summer. My quality of life is lower than it has ever been. I don't know how I can work any harder or any more just to afford to live in Worcester County where the cost of living is so high and the teacher pay is so low. When I graduated from college, Worcester was the county where everyone aspired to work. I am appalled at how the leadership of our county has devalued our education system over the years. We are one of the highest performing counties in the state, yet college graduates do not want nor can afford to teach here. Our teachers are working harder than ever yet we are THE lowest paid county in the state. Our schools are winning championships, graduating top students, and are full of opportunities for students, yet the media is encouraged to focus on the negative to paint an unfavorable picture in the minds of the public. I am confused as to how devaluing our education system will benefit our county. Our county leadership should be fighting to support our schools, our students, and our teachers. It is clear there is a political agenda and smear campaign that is at play in the current budget process and our teachers are the ones paying the price. 

Attached are my public comments to be read:

I implore you to fully fund the budget for Worcester County Public Schools. We recognize that several of you believe that you feel WCPS needs to "reimagine" the budget, as Commissioner Bertino stated, but not funding the budget fully would lead to the loss of 90 positions. That cannot be reimagined; that is a fact that has consequences for everyone in Worcester County. Many of you question the spending of WCPS. Spending cuts alone will simply not make up enough to run our schools without having serious consequences felt by students. This isn't an opinion but a mathematical fact. Your desire to micromanage spending and usurp the role of our Board is holding children and teachers hostage.

Commissioners have claimed that you aren't the ones cutting positions but our board decides how that money is spent. However there simply is not enough to cut in the budget to make up the \$9 million shortfall caused by funding us at MOE. Some of you claim teachers deserve to be paid more. However, the only way to pay these teacher salaries that you say they deserve without fully funding the budget would require cutting positions and larger class sizes. Commissioner Fiori claims that he "loves teachers." However, how are you showing you love these teachers by forcing larger class sizes upon them when they are pleading to keep classes small? The only way to both pay the teachers what they deserve and keep classes small is to fully fund the budget.

It is sad that this is the only time you hear from the public given that four of you voted down the right to have public comments at county meetings, making us the only county on the Eastern Shore to not allow this and subsequently besmirching our reputation across the state. It's ironic that some of you voted this way, especially Commissioner Abbott, since you have publicly pleaded, according to your Facebook on March 8 and March 18 for your likeminded constituents to speak at Board of Education meetings. It appears you are more concerned about ensuring the Board of Ed hears from citizens than you are about letting those same citizens speak to you in a public setting.

This groundswell of support that you are seeing will continue to grow if you do not fully fund this budget. I am respectfully writing today in support of fully funding the Worcester County Board of Education's (BOE) budget for the upcoming school year of 2024-2025 of \$109.6 million. Per the *Ocean City Today-Dispatch* article dated May 2, 2024, the total county expense budget has been requested at just over \$270 million. As a daughter of a teacher and graduate of Worcester County Public Schools, I am writing to express my support for fully funding the Worcester County Board of Education in FY 2025. While there are important considerations when balancing a budget that require careful deliberation, there is nothing difficult about deciding whether or not to support children and families in Worcester County.

As a tourist destination with very few options for sustainable year-round employment, WCPS is an incredibly important lifeline for Worcester County families. As of 2023, WCPS employed approximately 1,300 individuals and is one of the largest employers in the area. Opting for maintenance-of-effort funding once again would guarantee the elimination of many of these positions and cause financial catastrophe for families. It will also result in losing qualified education professionals who will leave WCPS and travel to other counties with budgets that reflect the value they place in education. WCPS also serves approximately 6,700 students. Quality public education should be a guarantee, not a privilege to be purchased. The students that will be impacted the most by your decision will be the ones with the least amount of recourse if you turn your backs on them.

As a reminder, Worcester County receives the lowest per pupil state funding contribution of any Maryland county according to the OC Today-Dispatch. That you know better than they do. You may be experts in your own fields of choice, but you are not education professionals. My name is Meg Lawrence, and I am a teacher at Stephen Decatur Middle School. I currently live in Berlin, but I am not originally from this area. I moved here after college to live and teach in Worcester County because of the school system's prestigious reputation. Being new to the area, I did not know much about it, but I knew one thing – Worcester County was one of the best school systems on the Eastern Shore, if not all of Maryland. If I was going to move away from home, it was going to be to Worcester County.

For many years, I knew I made the right choice. I met people over the years who had also made the move from “across the bridge” as I had because of the county's reputation. Who wouldn't want to live at the beach and also receive a top-notch education? There is a reason Worcester is so desirable: smaller class sizes, updated curriculum, one-to-one technology, new and updated facilities, teachers who are excited and proud to come to work each day, and most importantly, successful students.

However, a budget funded at maintenance-of-effort diminishes all of that. Class sizes become larger as staff positions are cut to adjust to the cost of living. Curriculum resources and technology become outdated because new ones cannot be purchased. Facilities fall to the wayside. Teachers are forced to work second or even third jobs on nights and weekends to support their families, meaning that their time and energy are divided, and students are not receiving the best education possible. Lastly, students are not as successful and fall behind their peers because programs such as after-school and summer academies are cut. These programs are invaluable to our students but were some of the first on the chopping block this past year.

Please accept my apology for not being able to speak in person this year, and accept our gratitude for the many years which the Commission has chosen to support the suicide prevention mission of the Jesse Klump Memorial Fund.

Everyone on the Commission is familiar with the work that we do on the lower Eastern Shore, as reflected by your past generosity. For the coming fiscal year we have requested a grant of \$5000. This will enable us to launch and expand a new program: a Local Outreach to Suicide Survivors (LOSS) Team. The LOSS Team is modelled after other teams in place nationally, and serves those families and loved ones left behind after a suicide.

Our President, Kim Klump, has hosted monthly support groups for survivors of suicide loss since early 2011. She trained with the American Foundation for Suicide Prevention as a grief counselor, and is assisted by a member of the Worcester County Health Department's Crisis Response Team. Kim is the coordinator of the LOSS Team, and has already enlisted 12 volunteers to act as outreach representatives.

Newly bereaved family members are often at a loss themselves after a suicide death. Their odds of making an attempt on their own lives are magnified. They are faced with an unimaginable kind of grief, complicated by its unexpectedness, and factors emotional, financial, and logistical. They feel alone, as if no one else has ever experienced such a devastating loss. Members of the LOSS Team have all been there, and their role is to reach out with the message "I know how you feel, I lost someone to suicide, too." Team members will be prepared with connections to resources that address every issue bereaved folks may have, gently and compassionately.



Team members will not be on the scene of a suicide, and will not interfere with subsequent investigations by law enforcement. It is not our intention to be intrusive, nor is it our intention to force our services on those grieving. Often, just learning that someone has shared their experience and is there to listen is a door that opens to hope.

The LOSS Team is partially financed by a grant from the Everytown Foundation, a grant that requires matching funds. The generosity of the Commissioners Will be a huge help toward making the LOSS Team effective, saving the lives of your neighbors.

Thank you for considering our application. We know that there are many worthy nonprofits in Worcester County (we work as partners with many of them) and that your decision is difficult. Simply your consideration affirms the importance of our work.

Thank you, commissioners, for allowing me to submit my comments despite being unable to attend this evening.

This is my twenty-first year as a teacher in Worcester County. I taught Language Arts my first four years and have taught English as a Second Language since. Prior to coming to Worcester County, I taught for seven years in Accomack County and was one of eight finalists for the state of Virginia Teacher of the Year during my last year there. As a native and resident of Accomack, I hope to share an “outsider’s” perspective that will, hopefully, resonate with you.

After deciding to stay on the Delmarva Peninsula, I sought employment in Worcester County because it was the gold standard in teacher salaries on the Eastern Shore at that time. If you look at the number of employees who were hired from Accomack County in the early 2000’s, you will see that many teachers recognized this.

I urge you to notice and acknowledge that we are now beginning to feel the same rumblings of attrition amongst Worcester educators that I once witnessed in Accomack. Teachers are talking about other counties' salary scales; newer hires are deciding if the demands of the job are worth the pay; and fewer teacher interns are in our schools compared to fifteen years ago. Accomack still deals with significant shortages due to teacher attrition despite having increased salaries significantly over the past several years; I expect the same fate will befall Worcester if you do not take action to re-establish Worcester as the highest-paying school district in Maryland. You do not want Worcester to be in the position of playing “catch-up” like your southern neighbor.

Finally, I’d like to encourage the elected officials of Worcester County to demonstrate professional decorum in their interactions with one another and with the public on social media. The incessant bickering, one-upmanship, and tension have unnecessarily demoralized this county’s educators more than you know.
